MAYOR'S REPORT

Mayor Spango thanked the members of the Department of Public Works (DPW) for their efforts during the recent snow storm. Mayor Spango reported that the Borough's proposed spring and summer activities will be announced at the next meeting.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi announced that there will be a budget presentation at the March 21st meeting, after which the 2023 municipal budget will be introduced.

PUBLIC WORKS

Councilman Freda commented that the DPW did a great job in response to the recent snow storm.

PUBLIC SAFETY

Council agreed that the cost to refit fire hydrant in the Borough with five-inch Storz quick connect adapters will be added to the capital budget. The DPW will install the adapters which will decrease the projected cost.

RECREATION

Councilman Trillo announced that four of the six basketball league championships have been won by Roseland teams. A fifth championship is guaranteed because the final championship game will be played later this week between two Roseland teams. Registration for summer softball and baseball programs has closed and a waiting list has been established.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli reported that the committee reviewed a possible shared services opportunity to provide vehicle fuel for board of education vehicles. Council agreed with the committee's recommendation that the board of education will be allowed to use the Borough's fuel pumps on an emergency basis only. The Beautification Committee is reviewing options for cleaning up the corner of Passaic and Eagle Rock Avenues. Caldwell has drafted the 2023 shared services agreement for the senior citizens bus, but Caldwell is awaiting administrative approval before forwarding the agreement to Roseland. Council agreed to reschedule the November 7th Council meeting from election night to Thursday, November 9th.
