APPROVAL OF BILLS

Councilwoman Tolli made a motion to approve Resolution No. 125-2023 approving the March 31, 2023 bill list in the Amount of \$227,609.26. The motion was seconded by Councilman Bardi and approved by a 5-0 voice vote (Freda absent).

The motion was seconded by Councilwoman Fishman and approved by a 5-0 voice vote (Freda absent).

CONSENT AGENDA

Councilwoman Perrotti made a motion to approve raffle application no. RA-397 from Alzheimer's New Jersey to conduct an off-premise merchandise raffle on June 30, 2023. The motion was seconded by Councilwoman Tolli and approved by a 5-0 voice vote (Freda absent).

MAYOR'S REPORT

Mayor Spango announced that there will be a ribbon cutting ceremony on April 24th, at a time to be determined, at Stella's Restaurant at 33 Eisenhower Parkway. Mr. Spango initiated a discussion on safety concerns of lithium batteries. The primary concern is the development of safety precautions at multiple family complexes where dwelling units are attached or very close together.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi reminded residents that the public hearing on adoption of the 2023 municipal budget is scheduled for the April 18th Council meeting.

PUBLIC WORKS

PUBLIC SAFETY

Councilwoman Perrotti commented on her experience while attending a recent fire department training exercise. The fire department practiced using new battery-operated tools for vehicle extrication.

RECREATION

Councilman Trillo announced that opening day of baseball and softball season is scheduled for April 22nd, weather permitting. The baseball fields are in great shape. Roseland children will be participating in shared softball teams with Fairfield and Essex Fells.

Mayor Spango added that one hundred children registered for Easter activities last year, and two hundred twenty-five children registered this year.

Mr. Trillo noted that he expects that the proposed improvements to the dugouts at Fernwood Field, which include an American flag mural and town seal mural, will be completed in the near future. Mr. Trillo stated that with the opening of the new pickle ball courts, discussions are taking place about adding pickleball lessons for youths and adults. Rules and procedures are also under consideration to ensure that Roseland residents receive priority over non-resident users when reserving pickle ball courts. Rules may include reservation of certain courts for residents only, and fees for non-resident users.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli reported that the new three-year contract for shared services for the senior transportation bus are in their final stage of review by Caldwell officials. Ridership by Roseland residents increased by thirty-two trips in March. The Beautification Committee is preparing flowers and planters that will be displayed around town. Student members of the Municipal Youth Guidance Subcommittee assisted with the Easter Bunny activities. The students also have a trip planned to the Community Food Bank in Hillside.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman expressed her excitement with the start of excavation for new buildings on Livingston Avenue. Members of the senior society recently took a trip to observe the Cherry blossoms in Essex County, and they are planning additional events for the summer. Council approved a resolution earlier in the meeting, which authorized the seniors to take a trip to the Black Forest Inn in Stanhope on October 13th for Octoberfest. Council also approved the extension of the NJ Division on Mental Health and Addiction Services grant funding from March 15th through June 30th due to decreased state funding.

Councilwoman Perrotti made a motion to approve the March 21, 2023 Council meeting minutes and the March 21, 2023 executive session minutes. The motion was seconded by Councilwoman Tolli and approved by a 5-0 voice vote (Freda absent).
