

ORDINANCE NO. 02-2022

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

BOND ORDINANCE AMENDING SECTION 3(a) OF BOND ORDINANCE NUMBERED 11-2011, AS AMENDED BY BOND ORDINANCE NUMBERED 10-2017 AND SUPPLEMENTED BY BOND ORDINANCE NUMBERED 15-2018, OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY, FINALLY ADOPTED SEPTEMBER 20, 2011, AS AMENDED AUGUST 15, 2017 AND SUPPLEMENTED NOVEMBER 13, 2018, IN ORDER TO AMEND THE DESCRIPTION OF THE PROJECT.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(a) of Bond Ordinance numbered 11-2011, as amended by Bond Ordinance numbered 10-2017 and supplemented by Bond Ordinance numbered 15-2018, of the Borough of New Roseland, in the County of Essex, New Jersey (the "Borough"), finally adopted September 20, 2011, as amended August 15, 2017 and supplemented November 13, 2018, is hereby amended to include the acquisition of a generator for a pump station, the installation of an altitude valve on the existing tank and the transport, installation, disinfection and testing of a second water tank, including a concrete slab and piping, and to read as follows:

"(a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is various improvements to the Water/Sewer Utility, including, but not limited to, the installation of manholes and check valves, the relining and replacement of water mains, improvements to Fire Booster Pump Station, Booster Pump Station and Grinder Unit Main Pump Station, the Sewer Flow Meter Replacement Project, a new water meter reading system, improvements to the Borough's water tower, the acquisition of a generator for a pump station, the installation of an altitude valve on the existing tank and the transport, installation, disinfection and testing of a second water tank, including a concrete slab and piping, including all work and materials necessary therefor and incidental thereto and further including all related costs and expenditures incidental thereto."

Section Two. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Three. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.




