# AN ORDINANCE OF THE BOROUGH OF ROSELAND ESTABLISHING SALARIES FOR THE MAYOR AND COUNCIL OF THE BOROUGH OF ROSELAND

WHEREAS, the Borough of Roseland desires to establish the salaries to be paid to the Mayor and Council;

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Roseland, County of Essex, State of New Jersey as follows:

## **SECTION I**

That the salary or compensation for the following officials of the Borough of Roseland shall be established as follows:

<u>Position</u>	<b>Annual Salary</b>
Mayor	\$7,500.00
Council Member with No Benefits	\$5,000.00
Council Member with Benefits	\$3,134.00

## **SECTION II**

All provisions of this Ordinance are subject to the available appropriations of the Borough of Roseland and that this Ordinance does not and shall not legally bind the Borough of Roseland to pay any of the wages or compensation set forth herein unless and until appropriations have been made in sufficient amounts to pay said wages or compensations to those holding the title and positions set forth herein.

## **SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

## **SECTION IV**

This ordinance shall take effect immediately upon its proper publication after passage in the manner provided by law.
