**AN ORDINANCE OF THE BOROUGH OF ROSELAND TO REPEAL
ORDINANCE NO. 16-2022 AS AMENDED WHICH PROVIDED FOR
SALARIES AND COMPENSATION TO BE PAID TO NON-UNION
EMPLOYEES OF THE BOROUGH OF ROSELAND AND
SUBSTITUTE THEREFORE SALARIES AND COMPENSATION FOR
THE YEAR 2022**

BE IT ORDAINED by the Mayor and Council of the Borough of Roseland, County of Essex, State of New Jersey as follows:

SECTION I

The following minimum and maximum salaries and other remuneration shall be paid to the non-union employees of the Borough of Roseland in accordance with the provisions of this Ordinance as set forth below, and shall be amended by adding the following **thus** and deleting the following **thus**:




