

ORDINANCE NO. 06-2020

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE TO AMEND CHAPTER 14 "PARKS AND
RECREATION" TO MODIFY PERMIT FEES, FOR NON-
SANCTIONED GROUPS, ORGANIZATIONS, OR ACTIVITIES
USE OF CERTAIN FIELDS**

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter 14 entitled "Parks and Recreation", to modify the permit fees for certain fields for use by non-sanctioned groups, organizations, or activities;

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Roseland that 14 entitled "Parks and Recreation" of the Revised General Ordinances of the Borough shall be amended as follows:

SECTION I

That section 14-4 "USE OF OUTDOOR FACILITIES" shall be amended by adding the following **thus** and deleting the following **thus**:

14-4 USE OF OUTDOOR FACILITIES

14-4.1 No Change

14-4.2 Permit Fees.

- a. No change
- b. Fields with no lights shall be for two (2) consecutive hours
 - 1. Lynn DeBell Field ~~\$90.00~~ **\$145.00**
 - 2. Thomas J. O'Beirne Field ~~\$90.00~~ **\$145.00**
- c. Permits issued for Fields with Lights shall be for two (2) consecutive hours
 - 1. Thomas J. O'Beirne Field ~~\$115.00~~ **\$170.00**
- d. **Off Season Fee for Lining Fields \$50.00**

SECTION II

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

This ordinance shall take effect upon publication as provided by law.




