**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER 14 OF THE
REVISED GENERAL ORDINANCES OF THE BOROUGH
OF ROSELAND ENTITLED "PARKS AND RECREATION",
SECTION 14-3 ENTITLED "SANCTIONED GROUPS,
ORGANIZATIONS OR ACTIVITIES"**

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter 14 entitled "Parks and Recreation", Section 14-3 of the Revised General Ordinances of the Borough of Roseland entitled "Sanctioned Groups, Organizations or Activities" to clarify the use of recreation facilities by Sanctioned Groups and Organizations;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Roseland that Chapter 14 of the Revised General Ordinances of the Borough of Roseland entitled "Parks and Recreation", Section 14-3 entitled "Sanctioned Groups, Organizations or Activities" shall be amended as follows:

SECTION I

That Subsection 14-3.3 entitled "Sanctioned Groups, Organizations - Use of Recreation Facilities" shall be amended by adding the following **thus** and deleting the following **~~thus~~**:

14-3 SANCTIONED GROUPS, ORGANIZATIONS OR ACTIVITIES.

14-3.3 Sanctioned Groups, Organizations - Use of Recreation Facilities.

Sanctioned groups and/or organizations may use any Borough recreation facilities when available, **except artificial turf facilities**, **~~and~~** upon approval of the Recreation Director.

14-3.4 No change

14-3.6 No change

SECTION II

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

This ordinance shall take effect upon publication as provided by law.


