# AN ORDINANCE TO AMEND CHAPTER 2-6 ENTITLED "STANDING COMMITTEES OF COUNCIL"

**NOW, THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Roseland that Chapter 2 of the Revised General Ordinances of the Borough of Roseland entitled "Administration" shall be amended as follows:

## **SECTION I**

That section 2-6 entitled "STANDING COMMITTEES OF THE BOROUGH COUNCIL" shall be amended by adding the following **thus**:

#### 2-6 STANDING COMMITTEES OF THE BOROUGH COUNCIL.

# 2-6.1 Standing Committees Designated.

The administration of all Borough departments, offices, boards, committees and commissions shall be conducted by the following Standing Committees of the Borough Council:

#### 2-6.2 Appointment of Members to the Standing Committees of Council.

Pursuant to N.J.S.A. 40A:60-7, the Council shall, by a vote of a majority of its members, appoint all Committee members to the Standing Committees of Council.

Pursuant to N.J.S.A. 40A:60-7, the Council shall, by a vote of a majority of its members, appoint all Committee members to the Standing Committees of Council.

#### 2-6.3 Authority of Standing Committees.

- a. The administration of the departments, offices, boards, committees and commissions shall be assigned to the respective Council Committees as follows in the following manner:

  - 5. The Council Committee on Community <u>Outreach and Shared</u> Services <del>and Outreach</del> shall be responsible for evaluating shared service opportunities and making

recommendations to better share resources across neighboring municipalities; and shall be responsible for such other offices, boards, committees or commissions as shall be assigned to it by the Mayor, with the advice and consent of the Council.

- 6. No change
- b. Each Standing Committee of the Borough Council shall be composed of three members of the Council appointed at the annual organization meeting, to serve until the next annual organization meeting of the Council. The Council shall elect one of its members to be appointed Chairperson.
- c. The offices, boards, committees and commissions which have not been specifically assigned to any standing Council Committee under the provisions of this subsection shall be assigned to Standing Council Committees at the annual organization meeting by the Mayor, with the advice and consent of Council.

# **SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

### **SECTION III**

This ordinance shall take effect upon publication as provided by law.
