**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 14
OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF
ROSELAND ENTITLED "PARKS AND RECREATION" ADDING
NEW SECTION 14-5 ENTITLED "USE OF PICKLEBALL COURTS"**

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter 14 of the Revised General Ordinances of the Borough of Roseland entitled "Parks and Recreation";

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter 14 of the Revised General Ordinances of the Borough of Roseland entitled "Parks and Recreation" shall be amended as follows:

SECTION I

That new section 14-5 entitled "Use of Pickleball Courts" shall be added **thus**:

14-5 USE OF PICKLEBALL COURTS

14-5.1 Adoption or Amendment of Rules and Regulations.

The Borough Council of the Borough of Roseland may, from time to time, make, adopt, amend and repeal, by resolution, rules and regulations for the operation and use of the pickleball courts. Such resolution adopting said rules and regulations shall be on file in the office of the Clerk of the Borough of Roseland and the Recreation Department.

14-5.2 Fees.

Any person wishing to use any Borough of Roseland pickleball court shall be required to first register and obtain an annual pickleball pass or be playing as a guest of a registered player with a valid guest pass. The fees for an annual pickleball membership are as follows:

(1) Resident annual membership fee for pickleball shall be \$10 per person per year (includes an annual guest pass).

(2) Nonresident annual membership fee for pickleball shall be \$200 per person per year.

(3) All pickleball fees shall be for the calendar year and shall not be pro-rated.

14-5.3 Violations and Penalties.

Any person or persons, firm or corporation who or which violates any of the provisions of this Section, shall be liable, upon conviction, to the penalty stated in Chapter 1, Section 1-5.

SECTION III

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION IV

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION V

This ordinance shall take effect in accordance with applicable law.


