

**ORDINANCE NO. 23-2021**

**BOROUGH OF ROSELAND  
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING AND SUPPLEMENTING  
CHAPTER 2 OF THE REVISED GENERAL ORDINANCES OF  
THE BOROUGH OF ROSELAND ENTITLED  
“ADMINISTRATION” TO AMEND SECTION 2-50 ENTITLED  
“MUNICIPAL YOUTH GUIDANCE COUNCIL”**

**WHEREAS**, the Mayor and Council of the Borough of Roseland wish to amend Section 2-50 of the Revised General Ordinances of the Borough of Roseland entitled “Municipal Youth Guidance Council”;

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that Chapter II of the Revised General Ordinances of the Borough of Roseland entitled “Administration” shall be amended as follows:

**SECTION I**

That section 2-50.1 entitled “Creation; Members; Terms” shall be amended by adding the following **thus** and deleting the following **thus**:

**2-50 MUNICIPAL YOUTH GUIDANCE COUNCIL.**

**2-50.1 Creation; Members; Term.**

There is hereby created a Municipal Youth Guidance Council, the members of which shall be appointed by the mayor with the advice and consent of the Council. The Municipal Youth Guidance Council shall consist of nine (9) members: one (1) member being a member of the Borough Council as Liaison and the remaining eight (8) members shall be Borough residents.

The term of each member shall **be one year and shall run concurrently with the respective school year** from **January-July** 1 through June 30 of the **said-following** year, and members may be reappointed.

**SECTION II**

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

### **SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

### **SECTION IV**

This ordinance shall take effect in accordance with applicable law.




