BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

ORDINANCE APPROPRIATING \$78,000 FROM THE CAPITAL IMPROVEMENT FUND FOR THE ACQUISITION OF POLICE EQUIPMENT IN AND BY THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY, AS FOLLOWS:

Section 1. \$78,000 is hereby appropriated from the Capital Improvement Fund of the Borough of Roseland, in the County of Essex, New Jersey (the "Borough"), for the acquisition of police equipment, including, but not limited to, mobile vision cameras, a video recorder and an alcotest machine and further including all related costs and expenditures incidental thereto.

Section 2. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.
