AN ORDINANCE AMENDING AND SUPPLEMENTING
CHAPTER 2 OF THE REVISED GENERAL ORDINANCES
OF THE BOROUGH OF ROSELAND ENTITLED
“ADMINISTRATION” TO AMEND SECTION 2-53
ENTITLED “MUNICIPAL ALLIANCE COMMITTEE”

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter 2 of the Revised General Ordinances of the Borough of Roseland entitled “Administration”, Section 2-53 entitled Municipal Alliance Committee;

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter 2 of the Revised General Ordinances of the Borough of Roseland entitled “Administration”, Section 2-53 entitled Municipal Alliance Committee shall be amended as follows:

SECTION I

That section 2-53.4, entitled “Establishment; Membership” shall be amended to add the following **thus** and to delete the following **thus**:

2-53 MUNICIPAL ALLIANCE COMMITTEE.

2-53.4 Establishment; Membership.

- a. There shall be a Roseland Municipal Alliance Committee which shall serve in an advisory capacity to the governing body in matters concerning the identification of alcoholism and drug prevention, education and community needs and implementation of programs formulated pursuant to this section.
- b. The membership of the Alliance Committee shall include broad representation of no fewer than 20 persons from the Borough. Membership may include, but shall not be limited to: a Mayoral representative; a member of the governing body; the Chief of Police or his/her representative; the President of the School Board or his/her representative; the Superintendent of Schools or his/her representative; a member of the Municipal Youth Guidance Subcommittee; a representative from each of the Parent Teacher Associations; a representative of the Chamber of Commerce, including, but not limited to, local business and industry representatives; a Municipal Court Judge or a representative of the court system; representatives of local civic associations; representatives of local mental health

agencies and local treatment and prevention providers; a representative of local religious groups; and private citizens, including youth representatives and youth and adults recovering from drug and/or alcoholic abuse. Members may be appointed by the Mayor **with the advice and consent of the Council** for alternately arranged terms of three years. Bylaws shall be adopted by the Alliance Committee and approved by the governing body.

SECTION II

That section 2-53.5, entitled "Appointments; Terms" shall be amended to add the following **thus** and to delete the following **thus**:

2-53.5 Appointments; Terms.

- a. The one representative of the governing body shall be appointed annually by and serve at the pleasure of the Borough Council.
- b. The one youth representative from the Municipal Youth Guidance Subcommittee shall be appointed annually and serve at the pleasure of the Borough Council during active membership on the Municipal Youth Guidance Subcommittee
- c. The balance of the members of the Committee shall be appointed by the Mayor **with the advice and consent of the** ~~Borough~~-Council and shall serve for a period of three years, except that the respective terms of office of the originally appointed members shall be as follows:
 1. Six members shall serve for terms of three years.
 2. Six members shall serve for terms of two years.
 3. Six members shall serve for a term of one year.
- d. The term of each member, except for the initial term, shall begin on the first day of January, and each member shall continue in office until his successor shall be appointed.

SECTION III

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION IV

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION V

This ordinance shall take effect in accordance with applicable law.




