ORDINANCE NO. 31-2021

BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED "ADMINISTRATION", ARTICLE VI ENTITLED "BOARDS, COMMITTEES, COMMISSIONS AND OFFICES"

WHEREAS, Ordinance No. 29-2019 was adopted by the Mayor and Council of the Borough of Roseland on October 15, 201 and became effective on October 24, 2019; and

WHEREAS, Ordinance No. 29-2019 eliminated the Citizen's Advisory Board; and eliminated the Municipal Youth Guidance Council and substituted in its place the Municipal Youth Guidance Subcommittee within the Municipal Alliance Committee;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter 2 of the Revised General Ordinances of the Borough of Roseland entitled "Administration" shall be amended as follows:

SECTION I

Chapter 2, Article VI, Section 2-50 entitled "Municipal Youth Guidance Council" is hereby deleted in its entirety.

SECTION II

Chapter 2, Article VI, Section 2-52 entitled "Citizen's Advisory Board" is hereby deleted in its entirety.

SECTION III

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION V

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION VI

This ordinance shall take effect in accordance with applicable law.
