

**ORDINANCE NO. 34-2021**

**BOROUGH OF ROSELAND  
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER III OF THE  
REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND  
ENTITLED "POLICE REGULATIONS"**

**WHEREAS**, the Mayor and Council of the Borough of Roseland desire to amend Chapter 3 entitled "Police Regulations", Section 2 entitled "Noise" in order to establish regulations for the use of landscaping and yard maintenance equipment;

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that Chapter 3 entitled "Police Regulations" shall be amended as follows:

**SECTION I**

Section 3-2 entitled "Noise" of the Revised General Ordinances of the Borough of Roseland shall be amended to add the following:

**3-2 NOISE**

**r. Landscaping and Yard Maintenance Equipment**

The operation of any noise creating landscaping equipment, including, but not limited to leaf blowers, lawn mowers, weed-whackers, hedge trimmers, etc., other than between the hours of 8:00 a.m. and 7:00 p.m. on weekdays, and between 9:00 a.m. and 6:00 p.m. on weekends. All motorized equipment used shall be operated with a muffler.

**SECTION II**

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect in accordance with applicable law.


