BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 14 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED "PARKS AND RECREATION" AMENDING SECTION 14-5 ENTITLED "USE OF PICKLEBALL COURTS"

BE IT ORDAINED by the Mayor and Council of the Borough of Roseland, County of Essex, State of New Jersey as follows:

SECTION I

That section 14-5 entitled "Use of Pickleball Courts" shall be amended by adding the following thus:

14-5 USE OF PICKLEBALL COURTS

- 14-5.1 No change
- 14-5.2 No change
- 14-5.3 No change
- 14-5.4 Fees.

The fees for an annual pickleball membership or a daily badge shall be as follows:

- a. Residents No fee
- b. Nonresident annual membership fee for pickleball shall be \$200.00 per person per year, except that the fee for nonresident senior citizens shall be \$75.00 per person per year. For the purposes of this section, senior citizen shall mean any person who is at least fifty-five (55) years of age or older.
 - 1. All annual pickleball fees shall be for the calendar year and shall not be prorated
- c. The fee for a single use daily badge shall be \$10.00 per person
- 14-5.5 No change

SECTION II

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect in accordance with applicable law.
