BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER II OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED "ADMINISTRATION" TO AMEND SECTION 2-50 ENTITLED "MUNICIPAL YOUTH GUIDANCE COUNCIL"

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Section 2-50 of the Revised General Ordinances of the Borough of Roseland entitled "Municipal Youth Guidance Council";

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration" shall be amended as follows:

2-50 MUNICIPAL YOUTH GUIDANCE COUNCIL.

2-50.1 Creation; Members; Term.

There is hereby created a Municipal Youth Guidance Council, the members of which shall be appointed by the Mayor with the advice and consent of the Council. The Municipal Youth Guidance Council shall consist of nine (9) members: one (1) member being a member of the Borough Council as Liaison and the remaining eight (8) members shall be Borough residents.

The term of each member shall run from January 1st through June 30th of the said year and may be reappointed.

2-50.2 Youth Subcommittee.

Youth Subcommittee members shall consist of any Roseland high school student (Freshman, Sophomore, Junior and Senior) in public or private high school. Their term shall run concurrently with their respective school year.

2-50.3 Purpose.

The purpose of this committee is to provide community service through a variety of activities and to develop good character traits that will help support lifelong achievements. Some community service events held in the past include Breakfast with the Easter Bunny, the Thanksgiving Food Collection, and the Roseland Community Bonfire.

2-50.4 Background Checks.

As of February 1, 2019, any adult resident appointed to the Municipal Youth Guidance Council shall submit to a background check in accordance with Chapter 2-38 of the Roseland Borough Code.

SECTION II

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect in accordance with applicable law.
