**ORDINANCE NO. 16-2017** 

BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

AN ORDINANCE OF THE BOROUGH OF ROSELAND, IN THE

COUNTY OF ESSEX, NEW JERSEY, PROVIDING FOR

REPLACEMENT OF POLICE EQUIPMENT IN AND FOR THE BOROUGH AND APPROPRIATING \$43,000 TO FUND THE SAME.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF

ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than two-thirds of all

members thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of the replacement of equipment used by the Borough's

Police Department, including but not limited to Camera Flashback System, Tough Book

Computers, Semi-Automatic Rifle and Equipment and Antenna Radar System, including all work

and related materials necessary therefor and incidental thereto, there is hereby appropriated the

sum of \$43,000 from the Borough's Capital Improvement Fund

<u>Section 2</u>. The capital budget or temporary capital budget (as applicable) of the

Borough is hereby amended to conform with the provisions of this ordinance to the extent of any

inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in

the form promulgated by the Local Finance Board showing full detail of the amended capital

budget or amended temporary capital budget (as applicable) and capital program as approved by

the Director of the Division of Local Government Services is on file with the Clerk and is available

there for public inspection.

<u>Section 3</u>. This ordinance shall take effect as provided by law.
